Dual Enrollment

Dual Enrollment is the opportunity for qualifying high school students to enroll in eligible courses at local public or private colleges. **Because Dual Enrollment entails enrolling and participating in college courses, the process of seeking out, finding courses, applying, and enrolling should be student driven.** This means counselors can aid students in each of these steps, but the ultimate responsibility for each step of the process is the student's.

Students may take

- courses that are not currently offered at Byron Center High School.
- courses that are offered at the high school but are not available due to unavoidable scheduling conflicts.
- courses must not conflict with your Byron Center High School class schedule. You may not leave a class early to attend a dual enrollment class.

Students may not take

- courses in physical education/wellness, theology, divinity, or religious ed.
- **courses that are 7-10 weeks, which are often half semester courses at local universities**
- courses for which there is an A.P. or online equivalent already offered by Byron Center High School.

To qualify, students must

- be in grades 9-12.
- earn minimum passing scores on at least one of the following standardized tests as below.
- submit applications and enrollment information by 4/15 for Fall Semester classes and 10/15 for the following Spring Semester classes.

Assessment	Test Section	Minimum Qualifying Score

Note: If a student does not earn a minimum passing score, he or she may still enroll in courses not represented on the assessments, such as world language, computer science, and fine arts.

FAQ's

What are the limitations on the number of college courses in which a student may enroll?

- **Students may NOT enroll in more than 10 overall** during his/her high school career, so
 - if a student enrolls in 9th grade: not more than 2 courses per year during 9th, 10th, 11th and not more than 4 during 12th.
 - if a student enrolls in 10th grade: not more than 2 courses during 10th and not more than 4 during 11th and 12th.
 - if the student first enrolls in 11th or 12th grade: not more than 6 during either academic year.

What does dual enrollment cost?

- Byron Center Public schools will pay approximately \$762.50 per course (rate is subject to change).
 - **Any tuition costs above this rate will be the responsibility of the student.**
- Students are responsible for fees associated with parking, transportation, and activities.
- If the student designates **high school credit only**, the district will pay for the books, but the books become the property of the school district.
- Students may be reimbursed for textbooks **only IF the books + tuition** do not exceed the fund allowance. **Keep your original receipt**
- Cost can vary from year to year depending on the class. Call the college/university administering the class and request the cost for the class selected (specify dual enrollment).

BE AWARE of the following.

- It is the **responsibility of the student** to **locate and purchase the textbooks needed for the course.**
- If the student drops the course(s) **after the college's drop date**, the **student is responsible to reimburse** the district for all tuition and fees.
- If the student does not successfully complete a course, the **student is responsible to reimburse** the district for all tuition and fees.
- It is the responsibility of the student to communicate enrollment changes directly with their high school counselor.
- Students that drop a dual enrollment course must enroll in a BCHS course. Students are required to maintain a full schedule (6 courses).

When can students take dual enrollment courses?

- Students may take college courses in the evenings, on weekends, or after school hours.
 - **Dual enrollment courses should match the school semester calendar as closely as possible. Courses running less than 14 weeks are not currently approved.**
- Students must have one free hour at the high school for a two or three credit class and two free hours for a four credit class. If a student does not take two free hours, he or she will be billed for any amount over the fund allowance for one course.

What type of credit do students earn through dual enrollment?

- Students must designate whether the course is for
 - high school credit
 - college credit
 - both high school and college
 - **Note:** Students can select different designations for different courses.
- **Students are responsible** for confirming that the dual enrollment credits will transfer to the colleges they plan to attend after high school. **NOT all credits are transferable.**

When do dual enrollment courses begin and end?

- The calendars for local colleges differ from BCHS (start/end dates and vacation).
- Students are responsible for knowing what those dates are and are expected to follow the calendar for the colleges they attend.
